## *Free Flu Shots Available Now! Protect yourself, and your family, with a flu shot this season!*



Flu season is here, and getting a flu shot is one of the best ways to keep you and your family healthy. With that in mind, California's Valued Trust (CVT) wants to make it as easy as possible to help our members fight the flu this season. And remember, the flu vaccine is covered at 100% as a preventive care benefit!

Influenza is a serious disease that can lead to hospitalization and sometimes even death. Every flu season is different, and influenza infection can affect people differently. Even healthy people can get very sick from the flu and spread it to others. An annual seasonal flu vaccine is the best way to reduce the chances that you will get seasonal flu and spread it to others. When more people get vaccinated against the flu, less flu can spread through that community.

## **CVT Wellness Plans**

### **Rewarding you for making healthy choices**

Are you currently enrolled in one of CVT's three 2016-17 Wellness Plans? Whether it is the *Wellness PPO Plan with Anthem Network*, *Wellness PPO Plan with Blue Shield of California Network* or the *Kaiser Permanente HMO Plan with Wellness Program* don't miss out on earning your \$400 in credits or gift card.

CVT's PPO Wellness Plans offer credits that are applied toward your out of pocket co-pays and deductibles, up to \$400 per year. To receive credits, you participate in various wellness activities. Each are assigned a credit value and are banked into your account until you incur a co-pay or deductible. At that time, if credits have accumulated, you'll receive a reimbursement check.

CVT's Kaiser Wellness Plan offers credits for similar health activities and are sent out in the form of Visa cash cards as you redeem your rewards at [healthworks.kp.org/cvt](http://healthworks.kp.org/cvt). This plan requires that you reactivate each year by signing on to the site and accepting the terms and conditions. All plans offer \$50 in credits just for enrolling each plan year which begins on October 1st. Now that's a healthy way to start the plan year!

## **Introducing a new preventive health benefit**

**SOLERA4ME** California's Valued Trust is pleased to announce Solera4me, a new preventive health benefit for Anthem Blue Cross members. It's a lifestyle change program that can help you lose weight, adopt healthy habits, and reduce your risk of developing diabetes.

The program is 16-weeks, and is available at no charge to Anthem PPO and HMO members who qualify.

There are a number of different options to choose from: some are national programs like Weight Watchers and Jenny Craig; some are online like HealthSlate and Retrofit; and still others are local programs you can attend in your community.

We're working with Solera Health who will help employees to determine if they qualify and then match them with the program that's the best fit. While the programs have different formats, most include the following elements:

- **A focus on making healthier food choices and increasing activity levels**
- **Weekly lessons**
- **1-1 interactions with a lifestyle health coach**
- **Tools like a wireless scale or activity tracker**

### A new safe and secure way for your health records to connect

Anthem is pleased to announce a new system that gives your doctors and emergency room providers quick access to your health history. Called Cal INDEX, it is a protected way for doctors treating you to have access to your health history for test results and medications. There are tight security measures and encryption techniques that keep your data safe. Social Security and financial data are not collected. CalINDEX only applies to members residing in California.
